How do we know that video footage is missing from Temores' MAV video?

Palo alto Police Officer Manuel Temores as well as fellow Officer April Wagner have asserted that video footage is missing from Temores' own MAV video.

Palo Alto Police Officer Manuel Temores' testimony during December 1, 2008 the Preliminary Examination.

Temores attempted to grab the arms of Ciampi. Ciampi resisted buy tensing and beginning to dart away from the van, toward the fence by the sidewalk.

I observed Chiampi lunge toward Ofc. Burger and saw Ciampi swinging his fists towards Ofc. Burger's head. I jumped near the suspect (about 1 yard away from where I was standing) trying to grab one of his arms from striking Ofc. Burger. Ofc. Temores also attempted to control the suspect when all three officers and the suspect fell to the ground on the sidewalk. I believe a laser activation may have occurred sometime during this altercation, because I heard verbally and by sound that a taser had been fired and saw the metal wire in the air. I heard Ofc. Burger say that he did not hit the suspect. The suspect continued to physically swing and fight our attempts to control. It did not appear that the taser had any effect on the suspect, because he still swing and pulled away from my grip.

The suspect got up off the ground and I attempted to gain control with another officer by holding him against the fence (by the sidewalk). At this time, the suspect hit the side of my head and face with either his head or elbow, as he was violently trying to get away from by grip. During this time I believe a second taser was deployed, because I heard Ofc. Temores say he was going to try the taser again and I heard the faser sound, and felt the activation through my body. I stepped back from the suspect, who went onto the ground on his hands and knees. It did not appear that the suspect had received the full current of the taser because at no time did he appear unable to control his actions. The suspect said that was enough and he did not want to get tazed anymore. The suspect was taken into custody by Ofc. Burger.

Both Palo Alto Police Officers April Wagner and Manuel Temores have stated in their official capacity under penalty of perjury that Ciampi got up off the ground prior to going down to the ground a second time all prior to being hand-cuffed.

There is no video footage in Temores' MAV video that depicts Ciampi going down to the ground two separate times and or getting up off the ground prior to being hand-cuffed.

Palo Alto Police Officers April Wagner and Manuel Temores are asserting that the video footage of Ciampi going down to the ground the first time and then getting up off the ground before going down to the ground a second time is missing from Temores' MAV video.

to exit the van. Ciampi did not listen to Officer Burger and instead started calling someone on a cell phone.

Fearing for not knowing if a weapon was near Ciampi and his uncooperativeness, I took my Taser (serial #X00-292417) out of its holster and activated it. I pointed my Taser, with red laser dot sight, at Ciampi's chest. Officer Burger and I ordered Ciampi out of the van. Ciampi was sitting on his bottom with his knees to his chest near the back of the van's interior. He told us he was not coming out and was calling his lawyer.

Officer Burger and I backed up a few feet to gain some distance. Ciampi did not come out of the van despite both Officer Burger and I were pointing Tasers at him. We approached the van and Officer Burger attempted to grab Ciampi with his right hand to pull him out of the van. Ciampi pulled away from Officer Burger and started to come out of the van.

The taser camera will automatically start recording at most 1.5 seconds after the taser gun is activated, (the safety placed in the armed position). According to Officer Temores' statement from the police report, he was recording Ciampi while Ciampi was in the back of the van.

There is no video footage on Temores' taser video that recorded Ciampi while Ciampi was in the back of the van's interior.

CONCLUSION: Temores is asserting that the video footage of Ciampi in the back of the van is missing from his taser video.

Palo Alto Police Officer Kelly Burger's testimony during December 4, 2008 the Preliminary Examination.

- 10 Q. Okay. So did you put it back -- at what point did you





It has already been established that Burger falsely stated under penalty of perjury that he placed his taser gun back in his holster and drew it a second time. Burger's had his taser gun in his hand the entire time from the moment he first drew his taser gun up to and beyond the moment he fired his taser gun. Exhibit

CONCLUSION: Ciampi is never seen facing Burger when Burger fires his taser gun at Ciampi, thus, the video footage of Burger is missing.



CONCLUSION: After Burger fires his taser gun, Ciampi backs up into the fence. Ciampi was not up against the fence as Burger testified to when he fired his Taser gun according to Burger's taser video indicating that video footage is missing.

Page 17 of Burger's MAV Transcript, Burger states that Ciampi was against the fence when Burger fired his taser gun.

At the 10:35:25 mark of Temores' MAV recording Ofc. Burger is pointing to where Ciampi was when he fired his taser gun, however, that does not match up with the video when Ofc. Burger fired his taser gun.

CONCLUSION: At no time is Ciampi up against the fence facing Ofc. Burger when Officer Burger pulls his taser gun and fires it at Ciampi. The actual video footage of Ofc. Burger pulling his taser gun and firing his taser gun is missing from Temores' MAV video.
