You claim that the taser had no effect, can you explain how and why electricity is being discharged through Burger's taser wire **7 seconds** after his Tamper Proof Taser Gun Data Port documents that he stopped discharging electricity.

Can you explain why the dialog of **"You're not making it easy,"** is not recorded onto Burger's MAV recording even though it was recorded onto Burger's Taser recording through a microphone that was in the same place as the MAV's microphone when both were recording at the same time?

CONCLUSION:

- 1) At the exact same time that Burger's MAV recording recorded *"Or I'm going to taser you,"* Burger's Taser CAM recording recorded *"Your not making it easy."*
- 2) Burger's MAV recording is missing the dialog of *"Your not making it easy."*
- 3) Burger's Taser recording is missing the dialog of *"Or I'm going to taser you."*
